
Manually Remove an Underlier From an Umbrella Policy

Description:

This job aid reviews how to manually remove an underlier. The process is the same regardless of which underlier is to be removed.

Job Aid Process (Cont.):

Step 4

On the *Underlying Policies* screen, you will remove the underlier.

Action

In this example, you will remove the Watercraft underlier.

- Select the checkbox to the left of the underlier to be removed.
- Click the **Remove Policy** button.

Action Screen

Click the **OK** button.



- Click the Coverages link.

Job Aid Process (Cont.):

Step 7

The Validation Results section informs the user Watercraft Liability coverage has been removed.

Action

 Click the Clear button to clear the message.

Note: The Watercraft Liability coverage has been removed in the *Underlying Coverages* section on the *Coverages* screen.

• Click the **Policy Review** link, to review the changes to the policy.


Step 8

Action

On the Policy Review screen:

• Click the **Quote** button.

Note: An "x" indicates the line item has been removed from the policy. A check mark indicates the line item has been added to the policy.




Step 9
