
Important Notice

In 2024 (for 2023 tax reporting) Nationwide will be sending 1099 forms between January 15-31st. These will be sent to the address on file for the agency number. There are no changes for 2023 tax reporting. However, in 2023 Nationwide stopped distributing 1099 forms to corporations due to feedback from agency partners and to better align with industry standard practices.

Agents requesting 1099 Information


1099 reporting information includes the following:

- P&C Commissions
- Bonuses
- Rewards Points/Awards/Trips values—Imputed Earnings
- Exclusive agent policies for NW Life & Annuity written before July 1, 2020 would be included in a 1099.
- Earnings are reported before deductions of Commercial Service Center and SA360 fees.
